CANDIDATE: This Declaration of Candidacy must be accompanied by the Petition of Candidacy signed by not less than 5 electors of your specific district or County. It must also be submitted to the County Clerk during candidate filing between March 3rd and March 14th, 2014.

COUNTY CLERK: Upon receipt of this Declaration of Candidacy:

1. Verify the Candidate is registered and is affiliated as an Unaffiliated voter.
2. Verify that the Petition of Candidacy is signed by not less than 5 electors.
3. Verify that the 5 electors are properly registered electors.
 - a. If the electors are required to be residents of the candidate's sub-district, verify that the electors are in the correct sub-district.
4. Stamp or write the date and time of receipt on the front of this document.
5. Complete the statement below.
