Petitions for consolidation of Good Roads Highway District No. 2 and Union Independent Highway District to a form a single consolidated highway district, to be known as Union Independent Highway District, were filed with the Idaho County Commissioners pursuant to Chapter 15, Title 40, Idaho Code. After public hearing on the petition, the Idaho County Commissioners entered an order directing that the question of consolidation of the two highway districts be submitted to the electors.

A general description of each current highway district provided with the petition is as follows:

Good Roads Highway District No. 2 is located in Idaho County, Idaho. The lands included within said district are more particularly described as follows: Township 31 North, Range 3 East, Boise Meridian, Sections 1, 2, 3, 10, 11, 12, 13, 14, 15, 16, 21, 22, 23 & 24; Section 4: E1/2; Section 9: S1/2, NE1/4, S1/2NW1/4, NE1/4NW1/4; Section 26: NW1/4, N1/2NE1/4, SW1/4NE1/4, NW1/4SW1/4; Section 27: N1/2, N1/2SE1/4, NE1/4SW1/4; Section 28: N1/2; Township 32 North, Range 3 East, Boise Meridian, Sections: 34, 35, 36; Section 33: E1/2. The market value of the lands within said district for assessment purposes is \$7,756,173.24. The district has no bonded indebtedness. The current warrant and other indebtedness for said district total \$1,500.00. The district had no ad valorem highway tax levy for the past year.

Union Independent Highway District is located in Idaho County, Idaho. The lands included within said district are more particularly described as follows: Township 31 North, Range 2 East, Boise Meridian, Sections 1, 2, 3, 4, 9, 10, 11, 12, 13, 14, 15, 16, 21, 22, 23, 24, 25, 26, 27, 28, 33, 34, 35 & 36; Township 31 North, Range 3 East, Boise Meridian, Sections 5, 6, 7, 8, 17, 18, 19, 20, 29, 30, 31 & 32; Section 4: W1/2; Section 9: NW1/4NW1/4; Township 32 North, Range 2 East, Boise Meridian, Section: 36; Township 32 North, Range 3 East, Boise Meridian, Sections: 31 & 32; Section 33: W1/2, The market value of the lands within said district for assessment purposes is \$20,857,695.60. The district has no bonded indebtedness. The outstanding warrant and other indebtedness of said district total \$8,796.38. The district had no ad valorem highway tax levy for the past year.
