Construction encompasses excavation of 6,620 CY of failed soil, partially re-constructing the outboard roadway prism using 5,135 CY of granular backfill, installing 1,365 LF of subsurface drains below the roadway, placing 2,200 SY of plant mix pavement, guardrail replacement and replacing a portion the existing culverts to improve site drainage.
