Minutes: The minutes of the 7/18/19 meeting were approved as corrected. Tara Nida resigned via email as secretary due to increased work load at Health and Welfare. Andrea Solberg was elected by unanimous vote to complete Tara's term as secretary.

Old Business:

Update on L.M. Lynda Fox reported the paperwork for guardianship of L.M. has been completed and filed. Lynda Fox and Alan Fox have officially been appointed to serve on behalf of ICBOCG as L.M.'s guardian. For future reference Lynda informed ICBOCG when completing paperwork for guardianship; paperwork must be completed from point of view of ICBOCG. Acting guardians must sign all ward paperwork on behalf of ICBOCG or as power of attorney. (POA)
Lynda reported:

- L.M. received her flu shot.
- L.M. received an MRI. It was discovered she has a hernia. No surgery to repair the hernia will be done at this point. Doing surgery now is risky due to her overall health. Doctor advised L.M. to work to meet weight loss goal before considering surgery and L.M. agreed to this.
- L.M. is full code (always resuscitate) due to her Developmental Delay diagnosis. If hernia does become serious by involving her bowel, Lynda and Alan must proceed to authorize surgery.

Update on L.B. Joan and Jerry Haaland reported:

- Inventory of L.B.'s property is complete and filed. A copy was given to GHR administrator, Ryan. He agreed to present it to L.B.
- Joan has contacted Social Security to request L.B.'s social security check be sent directly to the nursing home.
- L.B. has a property in Post Falls of which she is carrying the mortgage. This mortgage must be sold or paid in full for L.B. to qualify for Medicaid. The borrowers have been notified of this, but have not responded to Haalands inquiries asking them if they would like to refinance or pay the mortgage in full. It was moved, seconded and passed to have Lynda contact L.B.'s Guardian ad Litem, attorney, Matt Jessup for advice on this property. \$22,829.64 is remaining on the mortgage.
- L.B.'s daughter is currently living in L B.'s house on the Clearwater River with 3 cats. The dogs and birds are in foster care. The daughter will remain in the house for the winter. Haalands plan to put the house on the market in the spring after the house and property have been cleaned up. It will be a major project as the house is very full of stuff and the property overgrown. The assessed value of this real estate is \$88,000

- Haalands are currently trying to sell L.B.'s Impala.
- Haalands are working with June at GHR to get L.B. enrolled in Medicare Part D.
- Haalands have not purchased a burial plan for L.B.

New Business: Lynda received a type written referral from Dr. Told. This is not an acceptable referral. Lynda will follow up with Dr. Told and instruct him to fill out the ICBOCG Referral Form if he still wishes to move forward with this referral.

Klarey requested ICBOCG come to our next meeting dressed and groomed so we can take a new photo for our website.

Our next meeting will be January 16, 2020. The meeting was adjourned.
